

What is a Children's Services Fund?

The Children's Services Fund (RSM0 Section 67.1775) was established nearly 30 years ago by Missouri Law. The law allows counties through a voter approved tax to establish a fund solely for the purpose of establishing a community children's services fund for the purpose of providing services to protect the well-being and safety of children and youth nineteen years of age or less and to strengthen families.

JASPER COUNTY PROPOSAL

1/4 Cent sales tax generates

\$5 MILLION

annually for children in Jasper County

Average cost per family per year = \$52

How does it work?

- Jasper County Commissioners appoint a nine member board to disburse and oversee the funds.
- Nonprofit organizations and governmental entities may apply for funds outlined in the law.
- Board members cannot serve on the governing body, be employed by, or have a financial interest in a recipient of funds.
- Board may audit expenditures at any time.

Services may include:

- Temporary shelter for abused, neglected, runaway, or homeless children
- Outpatient treatment
- · Outpatient counseling
- Prevention programs to strengthen families
- Intervention programs
- · Counseling, therapy, evaluations, and screenings
- · Crisis intervention
- Respite Care
